The Indiana Department of Health, Environmental Microbiology Laboratory Certification Office, has reviewed your request to become an Indiana certified laboratory for the bacteriological analyses of public drinking water. Based on the submitted Kentucky document(s), and based upon the recommendation of the Water Microbiology Laboratory Certification Officer, the Indiana Department of Health issues the following determination:

Microbac Laboratories, Inc. is certified for Total Coliforms and E. coli by SM 9223B (Colilert MPN & P/A and Colilert-18 MPN & P/A), Heterotrophic Plate Count by SM 9215B (Pour Plate Agar), and Heterotrophic Plate Count by SIM Plate.

This certification is valid for the period ending December 31, 2024. Indiana certification has been continuous and uninterrupted since last issued, February 28, 2023.
